

Guidelines for Authors

Dear author,

We are happy you are writing for EPIKUR or are planning on doing so. In order for EPIKUR to be designed concisely please mind the following guidelines:

1. Continuous prose, please

Please write your contribution as a simple word or rtf-document, without special formatting (that is to say, for example, without formatting of head-lines, without different formatting of spaces between paragraphs, without separators)

2. Article or gloss, please

If you plan on discussing a topic objectively and in depth, if you want to work with citations and references, the form of an article is suitable. In case you are interested in elaborating on current events from a gastrosophical point of view and add a – maybe subjective – comment a gloss might be adequate.

3. An introduction text, please

If writing an article please put together an introduction text in the language of the article: maximum of 250 signs. This text is also triggered by search engines. If it contains most of the keywords of or text, it will be more likely that your text will be found in the web.

4. A bibliography, please

In case you cite literature or any other kind of media please put a list of all the titles you mention in the text at the end of your article. Please stick to the following citation rules:

- o <u>In text:</u> Use short titles with page references in footnotes: Bsisu, Arab Table, 41.
- Bibliography: Bsisu, May: The Arab Table. Recipes and Culinary Traditions. William Morrow Cookbooks, New York 2005.

Example for an article in an anthology:

- o <u>In text:</u> Use short titles with page references in footnotes: Gabay, Celebrating Christmas and New Year with Punch, 120.
- Bibliography: Gabay, Elizabeth: Celebrating Christmas and New Year with Punch. In: Mark McWilliams (Hg.): Celebration. Proceedings of the Oxford Symposium on Food and Cookery 2011. Prospect Books, Totnes 2012. S. 112-122.

In text: Use short titles with page references in footnotes: Fournier, Coping with new food-related risks, x.

 Bibliography: Fournier, Tristan: Coping with new food-related risks / Autour de la grippe aviaire du Viet Nam. In: Anthropology of Food 3 (2008). P. x - y.

- o <u>In text:</u> Use short titles in footnotes: Renton, Italian's plea.
- o <u>Bibliography:</u> Renton, Alex: Italian's plea: Please don't mess with our mozzarella. http://www.timesonline.co.uk/tol/life_and_style/ (20th March 2014). (→date of accessing the website)

5. A picture, please

Next to the introduction text of your article there is space for a picture or a photo. Please make use of this possibility and send us, for example, a portrait of yourself, a picture or a logo that corresponds to your contribution.

6. A suggestion for a review?

Your recommendation of a title that you think should be reviewed is most welcome. Suitable titles can be ordered from the publisher by the editorial office. Also your own review of a book will be gladly accepted. Furthermore you are invited to present your own new publication in EPIKUR.

7. Writing a review - please note

Please remember to always include your own (full) name as well as the full bibliographic title (incl. place, publisher and year of publication) of the book you are reviewing on top of your document.

8. An original text, please

Only new texts are to be published in EPIKUR. In justified exceptional cases only a re- or parallel publication is possible. In any case, please indicate if your text has already been accessible to the public.
